

Investment Objective

The investment objective of the portfolio is to provide investors with stable capital growth while maintaining a moderate level of income. The portfolio maintains a moderate risk profile and is limited to a maximum equity exposure of 40%. The portfolio complies with the investment guidelines governing retirement funds.

Risk Weighting:




Investment Commentary

The South African equity market, as measured by the FTSE/JSE All Share Index, reached a peak level of just over 55,100 points on April 24 this year. The fall in this index continued into early June, and even though it staged a brief rally later in the month, the fall has resumed as the Greek tragedy unfolds in Europe. As previously mentioned, our local equity market was very expensive and that some form of pull-back was expected. Often, in the absence of a suitable catalyst, equity markets can remain expensive for quite a while. The FTSE/JSE All Share Index has only fallen by -1.3% and the Rand has lost only -0.9% against the US dollar. Both of these moves are well within the current daily trading range for these two measures. In many local multi-asset portfolios, the small fall in local equities will be somewhat offset by the slight weakness in the currency. The local bond market is unmoved and the local listed property sector is down by -0.3% today.

South African equities are expensive and we are underweight this asset class. Our multi-asset portfolios are also characterised by offshore exposure that is close to the regulated maximum of 25% (in our retirement-funding portfolios). We are thus able to benefit to a significant degree if the global environment turns nasty and risk-aversion takes hold once again, usually leading to weakness in the ZAR which then acts as a good shock-absorber in portfolios. Local bond yields are attractive when viewed relative to official inflation. In offshore markets we prefer equity exposure to bond exposure.

Being in the market has been very rewarding for domestic South African investors over the last five years but now is the time to batten down the hatches and adopt a more defensive approach that brings portfolio risk closer to benchmark risk and then observe from a distance the ongoing global political and market drama. For the month of June the FTSE/JSE All Share Index returned -0.8%, Resources returned -7.1%, and Financials and Industrials giving returns of -0.5% and 0.6% respectively.

Characteristics, risk reward profile and nature of risks

Characteristics

This is a multi-asset low equity portfolio which means that it may invest in a spectrum of equity, bond, money market or real estate securities and tends to display reduced short term volatility and aims for long term capital growth. The portfolio may have a maximum equity exposure of up to 40% and a maximum property exposure of 25% at all times and complies with the regulation governing retirement funds. This portfolio may, at the discretion of the portfolio manager, invest up to 25% of the assets outside of South Africa plus an additional 5% of the assets in Africa excluding South Africa.

Risk Reward profile: Low

Typically, the lower the risk, the lower the potential return and the higher the risk, the higher the potential return. Market Risk
